THREE YOUTH PROVISIONS OF DIVISION X

1. REMAINING IN FOSTER CARE, RE-ENTERING FOSTER CARE, AND SUSPENDING SOME FOSTER CARE MAINTENANCE REQUIREMENTS (expire 10/1/2021)

Provision	Description	
a. Moratorium on aging out ¹	Agencies may not require youth to leave foster care solely due to age.	
b. Voluntary re-entry into foster care ²	Agencies must permit any youth who aged out of foster care between 1/27/20-4/20/21 (subject to extension) to voluntarily reenter foster care.	
c. Suspension of some requirements for IV-E foster care maintenance payments	 Agencies may not: find youth ineligible for title IV-E foster care maintenance payments due to age or failure to meet education or employment conditions;³ or find youth who re-enter foster care ineligible for title IV-E foster care maintenance payments due to age or failure to meet education or employment conditions.⁴ 	
d. Notice & public awareness campaign ⁵	Agencies must: • provide notice to youth who discharged from foster care due to age between 1/27/20-4/20/21 (subject to extension); and • conduct a public awareness campaign about voluntary re-entry for youth under age 22 who aged out between 10/1/19- 9/30/21. ⁶

2. CHAFEE FLEXIBILITIES AND ADDITIONAL FUNDING (Colorado is getting an additional Chafee allotment of \$4,302,679.⁷)

Provision	Description/Examples	
a. Increased age limit between 10/1/19- 9/30/21 ⁸	Chafee funding may be used to provide services/assistance to otherwise eligible youth younger than 27 who experienced foster care at age 14 or older.	
 b. Expansion of room and board funding and eligibility between 4/1/20-9/30/21⁹ 	 Agencies may use more than 30% of their Chafee funds for room and board payments. Room and board funds may be used for otherwise eligible youth aged 18-26 who experienced foster care at age 1 older. 	
c. Driving and transportation assistance ¹⁰	 Agencies may: Use Chafee funds to provide driving and transportation assistance to otherwise eligible youth aged 15-26 who experienced foster care at age 14 or older. Costs may be related to obtaining a driver's license, car insurance, driver's education classes and testing fees, practice lessons, practice hours, license fees, roadside assistance, deductible assistance, and assistance in purchasing a car. Cap of \$4,000 per year per youth. 	
d. Meeting moratorium on aging out and reentry requirements ¹¹	Additional Chafee funds may be used to pay for certain costs related to suspension of aging out, permission to reenter, and for additional protections for youth in foster care.	
e. Expanded uses of Chafee funding	CB PI at 11-12 provides a lengthy list of examples and Attachment D lists the purposes of Chafee programs.	
f. CB urges agencies to quicky provide youth direct financial support without many requirements.	 CB "urges all child welfare agencies receiving the additional Chafee to consider using at least a portion of the funds to facilitate quick and streamlined access to direct financial support for youth who were or are in foster care".¹² "We note that many state Chafee programs provide financial relief to youth. Some of these programs require that a youth complete an action plan, case plan, submit receipts, or other documentation as a condition of receiving the assistance. CB urges child welfare agencies to review all procedures to determine if they are a barrier to receiving needed assistance timely, specifically as viewed by youth and young adults."¹³ "Consistent with CB's commitment to youth voice and youth engagement, we encourage child welfare agencies to ask youth and young adults what they need and then, provided consistent with the law, work to provide those identified services and supports in a timely manner."¹⁴

EDUCATION AND TRAINING VOUCHER (ETV) FLEXIBILITIES AND ADDITIONAL FUNDING (Colorado is getting an additional \$625,389 ETV allotment.¹⁵) 3.

Provision		Description/Examples
a.		Agencies can provide ETVs to youth until youth reach age 27.
b.	Increased amount between 10/1/20-9/30/22 ¹⁷	Maximum ETV amount per youth increased from \$5,000 to \$12,000.
C.	Suspension of some ETV requirements from 4/1/20-9/30/21 ¹⁸	States may waive the requirement that a youth must be enrolled in a post-secondary education/training program or making satisfactory progress toward completing that program if a youth is unable to do so due to the pandemic. However , the Supporting Foster Youth and Families through the Pandemic Act does not modify/waive the requirement in the Social Security Act that a youth may participate in the program for no more than 5 years, whether those years are consecutive or not.
d.	Authority to use ETVs to maintain training and postsecondary education between 4/1/20- 9/30/21 ¹⁹	 Includes expenses that are not part of the cost of attendance. "Examples of these expenses include but are not limited to laptops or other technology necessary for virtual education; earbuds/earphones; desks, chairs and other items needed to create a learning space; supplies such as printer paper and ink; and tools for internet access (such as broadband internet access, cell phone data cards, routers and WIFI extenders)." "The [Children's Bureau] also reminds agencies that federal law allows ETV funding to be used for advanced degrees, as well as qualifying vocational education, and Associate's and bachelor's degree programs. Therefore, funding may be used to assist young people in attending law school, a master's degree, Ph.D., or other doctoral programs."
