# Checklist to Promote Perpetrator Accountability in Dependency Cases Involving Domestic Violence (Accountability Checklist)

Judges need information and tools to both guide them in holding perpetrators of domestic violence accountable for their abusive behavior and to ensure that efforts to reach perpetrators do not cause unintended consequences or further harm to victims of domestic violence and their children. This Accountability Checklist will help dependency judges intervene with those who use violence in ways that promote accountability and maximize the safety and well-being of children and victim parents. It provides a framework to help the court leverage its authority to hold perpetrators accountable, provide appropriate services, and improve judicial decisionmaking.

### Children, Domestic Violence, and Guns

This paper presents research evidence on the intersection of firearm use in domestic violence and the presence of children. It discusses threats against children, murders of children, and the psychological impacts to surviving children. While any domestic violence witnessed by a child can be damaging, and any threats or violence against children decreases their safety and is detrimental to their lives, the involvement of guns in these acts may make them particularly harmful due to a gun's lethality and ability to engender fear. It is therefore worth specifically examining the intersection of children, domestic violence, and guns.
