This bulletin explores research, intervention strategies, and resources to assist professionals in preserving connections among siblings placed in foster care or facing adoption. Sections address a legal framework for protecting sibling connections, the importance of siblings, sibling relationships in abusive/neglectful families, barriers to/benefits of placing siblings together, practices for keeping siblings together in placement, maintaining ties between separated siblings, sibling issues within foster and/or adoptive families, and resources for maintaining sibling sibling connections.
